The auditing shall be conducted at the Internews offices in Kabul, where the bookkeeping has been done. The auditor's assignment includes the following tasks:

- Conduct local Audit to meet Govt of Afghanistan requirement and to confirm accuracy of primary audit already conducted by internal and external auditors.
- Conduct Audit based on secondary data and compile standard financial report.
- Provide financial report in which income an expenditure is listed with confirmation that all vouchers exist.

Audit Report:

The Report of the public auditors must contain the following parts:

- All standard required financial statements separated by Projects
- Management and accountant letter to address any improvement and on health of financial management.
- Finance report including detailed list of inventories, income and expenditure.
- Express confirmation in the official certificate, that, accounts were substantiated by proper documentation
- All the expenditures shown in the financial report were properly documented by receipt conformance with structure and the financial plan was maintained,
- Funds were managed conservatively and economically, and compliance with contractual agreements and other requirements relating to the use of funds was maintained, and if necessary.
- Confirmation of the conformity with local conditions and adequacy of the personal expenditure
